Section 3: Hazards Identification

Potential Acute Health Effects:

Extremely hazardous in case of skin contact (irritant), of eye contact (irritant). Very hazardous in case of inhalation. Hazardous in case of ingestion. Prolonged exposure may result in skin burns and ulcerations. Over-exposure by inhalation may cause respiratory irritation. Inflammation of the eye is characterized by redness, watering, and itching. Evacuate the victim to a safe area as soon as possible. Loosen tight clothing such as a collar, tie, belt or waistband. If breathing is difficult, administer oxygen. If the victim is not breathing, perform mouth-to-mouth resuscitation. Seek medical attention.
